- Clearing the post-assessment is mandatory to proceed to the interview stage.

2 Final Interview Requirement

- STUDENT will be required to attend and successfully clear a final interview, which will be conducted in one of the following modes:
 a) Face-to-face offline interview (at an Academy-approved location) OR
 b) Online interview (via video conferencing).
- If STUDENT does not clear the interview, they may be provided with additional mentorship and a second interview attempt, at the discretion of the Academy.

4. Career Placement Assistance

• Upon successful completion of the post-assessment and final interview, STUDENT will be considered for an employment opportunity at 4AT Consulting LLP, the parent organization of 4AT Academy, based on availability and business requirements.

Dareer Opportunities with Partner Organizations

- If a suitable role is not available at 4AT Consulting LLP, the Academy will actively assist STUDENT in securing placement with one of its hiring partners.
- The Academy works closely with industry-leading organizations to facilitate career opportunities for students who meet the required standards.

Placement Conditions

- The Academy ensures that every effort will be made to connect STUDENT with suitable job opportunities based on their performance, employer requirements, and the selection process of hiring organizations.
- Placement is subject to STUDENT's successful completion of assessments, interviews, and alignment with employer expectations.

By signing this MOU, STUDENT agrees to:

- Actively participate in training sessions and mentorship programs.
- Adhere to all assessments, interview requirements, and Academy guidelines.
- Maintain professional conduct throughout the Program and placement process.
- Approach career opportunities with commitment and professionalism.

6. Non-Compliance & Termination

If STUDENT:

X Fails to clear the post-assessment and final interview after two attempts, placement assistance may be reconsidered.

X Violates professional conduct or fails to attend scheduled assessments/interviews, the Academy reserves the right to discontinue placement support.

7. Validity & Acceptance
